Contractor Fair

National Night Out

Brent Millis provided the committee with options if we close Beaver Ave for this event (August 1st).

- Iowa Plains \$4,900
 - Full service: includes placement and removal
 - Too expensive
- Bonnie's Barricades \$498.89
 - Full service: includes placement and removal
 - Reasonable if we want full service
- Quality Traffic Control \$1,000 Full Service or \$100 rental
 - Rental option would require us to place and remove signs ourselves
 - Good option if someone has a truck and willing to take this on.

The committee decided we will pursue the Bonnie's Barricades option. Brent will continue to work on the documentation needed with the city.

There was a question on what our BNA budget is for National Night Out. Don Piper was able to confirm we have \$2500 approved. Hopefully we will come in well under this based on previous expenditures.

Mega Scrub

The city of Des Moines has multiple times/locations for Mega Scrub (Spring Cleanup to Reduce Urban Blight). BNA participates with Lower Beaverdale Neighborhood and other neighborhood communities at the May 20th Mega Scrub at Polk County River Place (2309 Euclid Ave). Don Piper sent an email to Jeremy Geerdes (Lower Beaverdale Neighborhood) to see what involvement he plans as he has worked the volunteer list in the past. Jeremy has indicated he will be sending out communication yet this month. A to-do for our committee is to insure we have a good list of volunteers and neighborhoods involved. We collect donations at this event and distribute based on who volunteers. We also need to determine the proper way to distribute these donations (evenly split by community or based on volunteer number per community). We also discussed asking BNA board to be more involved in this event.
